Misdemeanor DUI in Arizona is a Class One (highest type of misdemeanor). In the chart are the minimum mandatory sentences except where otherwise stated. The maximum penalty for a Class One Misdemeanor in Arizona is 6 months in jail, 5 years probation (3 years for all but DUI), a \$2,500.00 fine plus an 80% surcharge and additional monetary assessment.
